and activities of the Office. The Transformation Office will centralise all program and project management work streams, prioritising and coordinating these processes to ensure that all capital and opex allocation is appropriately matched against Group wide priorities and that resources are managed effectively to ensure that we deliver on Vocus' commitment to our customers and on the strategic and financial outcomes expected by shareholders.

The Office will be headed by a new role reporting directly to the Group CEO. The Company will go through an internal and external recruitment process for the role and expects to have made the appointment by the end of the financial year.

Further detail on the programs being undertaken by the Transformation Office will be outlined at the Vocus Investor Day to be held on 14 June 2017. The strategy day will be webcast and available to access through the Company's website www.vocusgroup.com.au.
