Vocus appoints new CFO Mark Wratten

Vocus Group Limited (ASX: VOC) (Vocus) announces today the appointment of Mark Wratten as Chief Financial Officer (CFO). His appointment follows the resignation of former Vocus CFO Rick Correll on 21 September 2016. Mr Wratten will join Vocus on 16 January 2017 and will have a formal handover process with acting CFO John Allerton.

Most recently Mr Wratten was the CFO of ASX listed company Recall Holdings Limited (Recall) and left in May 2016 following the successful acquisition of Recall by Iron Mountain. Prior to becoming CFO of Recall and the demerger of that Company from Brambles Limited, Mark held a number of senior finance roles across Brambles (refer Appendix One for more detailed employment history).

Vocus CEO Geoff Horth said "We are very pleased to welcome Mark to Vocus. Mark's strong track record of finance leadership and transformation will be invaluable as we continue the work of integrating the recent acquisitions, and leveraging the world class trans-Tasman infrastructure platform we have established.

"I would like to sincerely thank John Allerton, who as well as being the Director of our Commercial and Regulatory activities stepped into the CFO role on an acting basis to ensure that the transition of our finance function to a unified platform did not lose momentum during this transition period" added Mr Horth
